Classes of Membership

Certificate: Certificate Membership is limited to 325 and is evidenced by a certificate signed by the President or Vice President and the Secretary or Acting Secretary of the Club under Seal and is hereinafter referred to as Certificate Membership. Bona fide registered owners of such certificates have a pro rata interest in the Club and are entitled to all the privileges of the Club, including the sole right to vote and hold office. If the member is under the age of 45 there is a 4% discount on dues and all capital fees for each year under 45 that the member is on January 1 of the current year. If the applicant for this membership is married, the age of the older spouse will be used in determining qualification for the discount rate.

**To be in Certificate Class the \$2,500.00 Certificate fee must be paid in full.

Non-Equity Certificate: All non-equity memberships shall be limited to 150 persons. Holders of this membership are entitled to all privileges of the Club, except those privileges reserved exclusively to the Certificate membership. Holders of this membership shall have no proprietary interest in the physical properties or assets of the Club. In the event of dissolution of the Club, this membership class shall not share ratably in the proceeds of any dissolution. Members in this category **may** begin purchasing a Stockholders Certificate and have six years to pay for the Certificate interest free. The payments must be made annually in an amount not less than 1/6 of the Certificate price. Monies paid toward the Certificate are non-refundable until the Certificate is paid in full. Members will not have voting privileges until the Certificate is fully paid. Upon payment in full members will be automatically transferred into Certificate Class.

Commencing January 1, 2011 the base rate for annual dues of this class of membership (Non-Equity) shall be approximately 6% higher than that of an Equity Certificate Member.

If the member is under the age of 45 there is a 4% discount on dues and all capital fees for each year under 45 that the member is on January 1 of the current year. If the applicant for this membership is married, the age of the older spouse will be used in determining qualification for the discount rate.

Social: Social Membership. Holders of this membership are entitled to all the privileges of the Club except golf and those privileges reserved exclusively for Certificate Membership. There is the opportunity for social members and their immediate family members to enjoy 5 rounds of golf at guest fees from opening day until September 30th and unlimited golf in October and November at special low rates. Plus, we added a \$750.00 junior golfing membership which Social members can purchase for a child below the age of 18.

Club House: This class of membership is unlimited in number. Holders of this membership are entitled to all the privileges of the Club except golf, tennis, swimming, and those privileges reserved exclusively for Certificate Members.

Non-Resident: Non-Resident Membership is limited to persons whose legal residence and place of business are more than 50 miles from the Clubhouse. Non-Resident Members shall be entitled to use all of the facilities of the Club except they shall not be permitted the use of the golf course more than 15 days per calendar year, including those appearances as a guest of a resident member.

Families of Members: The member's spouse, unmarried dependent children under 21 years of age residing with the member, unmarried children under 25 years of age attending college or professional school are entitled to the same privileges as the member as restricted by his class of membership. Notwithstanding the foregoing, a child of a member shall be eligible to maintain the privileges of their parent who remains a member of the Club for 365 days after such child ceases to be eligible under the foregoing portion of this paragraph.
